(A) - Hilary's Creek and lack of WBPS involvement at Nov. 15 meeting before, not after the fact of the Society especially when it will entail the destruction of existing vegetation and the building of two temporary access roads across surf smelt beds to build a new coho and cutthroat spawning pool. No plans at this point in time to place a viewing platform for children right behind the naturist beach which could put us in conflict with textiles. For a project that is only a monitoring plan, this has suddenly grown wings...with Streamkeepers, Markus, A Fisheries rep, her student who has only been monitoring in Pacific Spirit Regional Park, the acting manager for West Area. We were told that due diligence had to be in place before Markus could bring the plan to us for comment. He also told me that since Fisheries had set up that meeting, that it wasn't his place to let us know about the meeting. Both the Fisheries rep and Markus knew from discussions I held with both of them last summer that we did not want a viewing platform like at the Spanish Banks Stream because of the potential conflict between nudists and

clothed children whose parents could then complain about our sunbathing on the beach in line with the footbridge.

A heated discussion ensued. No permanent access road is tolerable. The Musqueam, WBPS and other citizens groups were not but should be included in planning.
